## *Clinical and Medicolegal Practice*

Dr Krabman conducted regular detailed clinical assessments of children, parents and families from throughout New South Wales in his role as Medical Director of Coral Tree Family Service from 2004 to 2011.

Since 2010, Dr Krabman has developed a special interest in medicolegal assessments relating to child and family issues, as a court expert in the Family Court of Australia and the Children's Court.

Dr Krabman maintains a busy clinical practice, providing treatment and advice to children, adolescents, and their parents.

Dr Krabman has become skilled in provision of treatment to children and families who are engaged in family law processes or are adapting to final orders, and is happy to be contacted by parents in this context, or by legal representatives enquiring about treatment for their clients. He does not provide treatment to families for whom he has prepared single expert reports. Currently he is only accepting such referrals where there has already been a single expert report or family report prepared, and he is able to be provided with a copy of the same.
